BOTH THE WHO GLOBAL LEPROSY PROGRAM AND THE ILEP TECHNICAL COMMISSION HAVE INDICATED THEIR VIEWS THAT FURTHER PROGRESS TOWARDS ERADICATING THE DISEASE CANNOT BE MADE WITHOUT NEW TOOLS, SUCH AS BETTER DIAGNOSTIC TESTS AND BETTER PREVENTIVE INTERVENTIONS, SUCH AS A NEW VACCINE.
